



ACPS Publishes Three New Books

In 2006, the Association of Chinese Political Studies (ACPS) held its annual meeting at University of Louisville, and co-sponsored an international conference with Renmin University of China in Beijing. Three books have been produced from the selected papers presented to the two conferences.

Shiping Hua and Sujian Guo, eds., *China in the 21st Century: Challenges and Opportunities*, Palgrave-Macmillan Publishers, August, 2007.

This edited volume looks at China in the twenty-first century from a holistic perspective. Each of the ten authors emphasizes a particular dimension of politics, political economy, political culture and foreign policy focusing on a specific issue within the broader dimension. Each specific issue, such as the so-called harmonious society, the internet, and technocratic leadership, serves as a window through which the reader can glimpse through to understand China in the new century

Sujian Guo and Shiping Hua, eds., *New Dimensions of Chinese Foreign Policy*, Roman and Littlefield Publisher, July, 2007,

This edited volume is an in-depth analysis of China's new place in international affairs. Taking Hu Jintao's proposal for "peaceful development" as a starting point, the contributors in this volume examine the new trends of thought in the fourth generation of Chinese policymakers. Special emphasis is placed on US-China relations. Editors Sujian Guo and Shiping Hua have assembled a


list of contributors—many of which are Chinese or Chinese-American scholars—with thorough knowledge of changes in Chinese foreign policy and their implications for the world. The essays contained in this volume cover a comprehensive breadth of topics, including: China's changing ideology in foreign policy, Chinese elite perspectives on the rise of China, the political orientations of the emerging elite, social dimensions of China's power status, "soft power" management, approaches to the North Korean nuclear issues, Middle East foreign policy, entry into WTO and foreign trade policy, changing attitudes toward international regimes, and the implications of China-U.S. interdependence. *New Dimensions of Chinese Foreign Policy* is essential reading for any student or researcher of contemporary Chinese politics.

Sujian Guo & Baogang Guo, *Challenges Facing Chinese Political Development*, Lexington-Rowman & Littlefield Publishing, September 2007.

This edited volume is based on the ACPS co-sponsored Beijing conference on "Political China in the 21st Century" held at Renmin University of China between June 10 and 11, 2006. Each author tries to carry scholarly objectivity into their research in order to closely examine a particular dimension of Chinese political development. Their insightful analyses can serve as windows through which readers can glimpse through these multifaceted angles to learn about various challenges facing China in its search for modernity, democracy, and the ways Chinese society is dealing with these challenges.

New Books from ACPS Members

Bo Zhiyue's new book, *China's Elite Politics: Political Transition and Power Balancing*, is published by World Scientific Press recently. This book provides a new theoretical perspective on elite politics in China and uses this theoretical perspective to explain power transfer from Jiang Zemin to Hu Jintao and political dynamics between different factional groups since the Sixteenth Party Congress of November 2002. It explains the transition in structural terms, presents characteristics of China's political elites, and analyzes the balance of power among formal institutions as well as among factional groups. It



also examines political interactions between Jiang Zemin and his cronies on the one side and Hu Jintao and his allies on the other over a number of issues: the epidemic of severe acute respiratory syndrome (SARS); ideological institutionalization; the politics over economic overheating; Jiang Zemin's complete retirement; and Hu Jintao's power consolidation in both ideological and personnel terms. As China is poised for the 17th National Congress of the Chinese Communist Party in the fall of 2007, this timely research will likely stir debate and discussion on China's elite politics.

Book Title: *China in an Era of Transition: Understanding Contemporary State and Society Relationships*

Edited by Reza Hasmath and Jennifer Hsu, University of Cambridge

Timed with an organized panel at the International Convention of Asian Scholars (Kuala Lumpur), this edited collection will focus on China's state-society relationship in an era of social transition. The overall aim will be to understand how state-society relationship has evolved since China implemented its economic liberalization policies in 1978; and what shape this relationship is at present and potentially in the future.

Contributors are invited, but not limited, to explore the following themes: Development of Chinese Civil Society (incl. Community Associations, NGOs, and GONGOS), State Power and Social Forces, Chinese Public Sphere, Society's Relationship with Various Levels of Government, eg. Central, Provincial, Municipal, etc., Responses from Various Sectors of Society to the Changing Nature of the State, Strategies or Policies Communities and the State have Developed for Engagement Research employing either quantitative or qualitative methods are welcomed.

All accepted contributions (7,000 words) will have to be completed by 1 November 2007 and will follow a stringent peer review process thereafter; with a view for publication in Spring 2008.
